Declassification of A356

The reclassification process is managed by the Highway Authority. Highways are organised through the Roads Classification System, along with the dedication of a primary route network to advise people of the recommended route to use.

The Highway Authority would need to understand what the reasoning is behind the request to declassify the A356. There are numerous issues to consider.

- Traffic volume is unlikely to decrease unless there are more suitable routes available.
- Where would the displaced traffic, assuming is does displace, relocate to.
- Cost: This would require surveys to understand the implications of declassification of the A356.
- Cost: Changes to a significant number of road signs would be required which is a financial burden that it is unlikely that the Highways Authority could meet.

Highways commented:

"A lot of work would be required before a decision on this matter could be made which we aren't currently in a position to resource or fund. If you wish to progress this further, then you will need to consider commissioning a survey. Following this we could consider and look at potential costs before making a decision, again, it is likely that we would not be able to fund at this time".
