47 TO RECEIVE THE CLERK'S UPDATE REPORT

The Deputy Clerk reported:

- The traffic survey associated with the planning application for 150 houses at the top of Kit Hill had commenced and would run from Monday through to Thursday. This had been co-ordinated by the Town Council and volunteer residents were collecting data which would be collated and presented to the Regulation Committee on Tuesday 17 September.
- Confirmation had been received from SSDC of their intention to name the 3
 roads on the North Street development Scutching Lane, Hackling Close and
 Retting Street. These names had been suggested by Cllr. Hartshorn and were all
 processes which would have taken place in the mills that once stood on this
 land.
- Cllr. Best had advised the Deputy Clerk to reapply for a licence to close Market Square to allow the Christmas market to go ahead. This had been done and the Deputy Clerk had been advised that there was a 10-week lead time and a fee of £210. Councillors agreed that this should be discussed at the next Full Town Council meeting.

- Cathole Bridge Road would be closed 20m either side of the level crossing to enable rail renewal works to go ahead. This would be effective from 8 October for 2 nights (23.45 05.45).
- Taylor Wimpey had postponed a planned meeting with Crewkerne Town Council to discuss the CLR and proposed another date of Monday 30 September.
- The planning application to SSDC from Crewkerne Town Council for the temporary electronic scoreboard on the George Reynolds Centre was now out for consultation.
