# 41 19/20 **TO RECEIVE ANY OTHER MATTERS OF REPORT**

- Cllr. Wakeman noted that many road closed signs had been put out in the surrounding roads and villages, with dates on them, but then often the road did not close. Cllr. Best confirmed that these road closures were related to work by a contractor employed by Highways.
- Cllr. Wakeman asked if the schools would be aware of the closure of Lyme Road, particularly Maiden Beech, as this would affect children reaching school on time.
   Cllr. Wakeman agreed to make the Head teacher of Maiden Beech aware, whilst the Deputy Clerk would contact Highways to ensure that schools and school buses were aware of the road closure.
- Cllr. Best reported that the pedestrian crossing on Market Street had been inspected by an engineer and the settings of the lights had clearly been amended as there was an improved traffic flow through the town. The Council agreed to monitor any feedback from members of the public.
- Cllrs. Aslett and Best reported on a site meeting they had held at Court Barton to
  investigate complaints by members of the public regarding parking in that area.
  Discussions included changing the parking angle to herring bone along with
  extending and adding double yellow lines in key spots. Cllr. Best would contact the
  Highways Engineer to put a proposal together and then take it to the residents in
  Court Barton for their comments.
- Cllr. Best stated that the proposed extension of the double yellow lines on Mount Pleasant would be added to the mandate form from Highways and would go into the newspaper this week.
- Cllr. Hartshorn reported that a Governor of a local school had received a report, in June, regarding the options for the education system in Somerset. Cllr. Hartshorn asked if the document was available. Cllr. Best confirmed that the document was not publicly available at this point.
- Cllr. Head noted that the hedgerow along Mount Pleasant was overhanging the pavement, making it very difficult for pedestrians to stay on the pavement,

alongside a busy road. The hedgerow belonged to a private residence and the Deputy Clerk was asked to send a letter to the property owner requesting the hedge be trimmed.
