The Deputy Clerk reported that the first notice for proposed Traffic Regulation Orders in Crewkerne had been received. These had been requested by our County Councillor and showed:

- Proposed double yellow lines at the Lyme Road/Lang Road junction.
- Proposed double yellow lines on Kithill near the traffic calming scheme.
- Introduction of no loading area from the museum to No 31 Hair & Beauty to prevent congestion at the roundabout.

The Deputy Clerk also reported that communication had been received from Somerset County Council regarding the SIS scheme, proposed by Highways, for the Market Street/South Street junction. A meeting was planned to discuss progression of officer led schemes, including this one.

The carrying out of internal alterations and the change of use from place of worship to single dwelling, alterations to boundary treatment and parking provisions.

Councillors expressed the following concerns:

- The report from the Conservation Officer was not available to view.
- Removal of a section of wall to allow for vehicle access.
- Car parking provision for a 4 bedroom property should be 3 spaces.
- Lack of storage space for bins and recycling.
