53 MTIG CAPITAL PRIORITY PROJECTS FUNDING AND SOUTH SOMERSET DISTRICT COUNCIL COMMUNITY GRANT FUNDING PRIORITIES

Councillors reviewed the list of recommended projects submitted by the working group and it was agreed that the refurbishment of the Falkland Square public toilets should be added to this list. Given the planned installation of EV chargers by SSDC in Crewkerne, it was also agreed that EV chargers would be removed from the list of projects.

55 **REQUESTS FROM CREWKERNE & DISTRICT ROTARY CLUB**

a) Charter Fair: to consider a request to use the Henhayes Car Park for market Stalls on Saturday 5 September

The Deputy Clerk reported that the request from the Rotary Club had now been withdrawn as the Charter Fair had been cancelled.

b) Painting of benches: to consider a request to adopt benches around the Town centre and to give them a “happy paint makeover”

Councillors gave their support to the Rotary Club’s request to adopt benches around the town and to give them a “happy paint makeover”, but requested clarification of the paint to be used and what consideration the Rotary Club had given to subsequent maintenance of the paintwork.

56 **CHRISTMAS LIGHTING UP NIGHT AND CHRISTMAS MARKET**
20/21 To consider whether planning should proceed on this year’s Christmas lighting up and Christmas market events

The Deputy Clerk reported that the Christmas Committee had been considering “low key” options for Christmas events, bearing in mind that social distancing restrictions would almost certainly still be in place. Councillors agreed to fully support the Christmas Committee’s efforts to organise events for the town.

57 **BARN STREET RECREATION GROUND**
20/21 To receive a report from Cllr. Aslett on the current ineffectiveness of the “no dogs” policy at the Barn Street recreation ground and to consider options to make the policy more effective

Cllr. Aslett reported that the current “no dogs” signage at the entrances to the Barn Street recreation ground was totally ineffective. He suggested that the Council investigate the option of instigating a Public Space Protection Order, in order to make the “no dogs” restriction more effective. Councillors agreed that this option should be investigated further and Cllr. Aslett kindly agreed to seek more detail.
