Minutes of the CREWKERNE TOWN COUNCIL meeting held in the Council Chamber on Monday 16 December 2019 at 6.45 p.m.

138 TO NOTE APOLOGIES FOR ABSENCE

139 MAYOR'S ANNOUNCEMENT

<u>Retirement of the Town Crier</u>: the Mayor thanked Mr. David Craner for his loyal service to the Council and the community in his role of Town Crier. She said that David had been a credit to the town and would be sadly missed.

140 **OPEN FORUM**

<u>North Street</u>: a member of the public and resident of North Street expressed his concern that there were safety issues relating to the traffic on North Street, particularly the HGV's. He emphasised that children and the elderly frequently walked along the narrow pavement.

The Chairman thanked the resident for his views and advised that the letter that he had written to the Council would be considered at the forthcoming Planning & Highways meeting on 13 January. She pointed out that the Council had recently discussed the possibility of having the road downgraded to B-road status, recognising that the process of downgrading was complex, especially so because the road crossed the Somerset/Dorset boundary. The Chairman also reiterated the position of Highways regarding the possibility of a one-way system being introduced, which was that such a change was dependent upon the construction of the link road which formed a key part of the CLR development.

Cllr. Best emphasised the importance of members of the public reporting any traffic-related incidents that occurred on North Street, as this would add further leverage to the case for action.

<u>Seagulls</u>: a member of the public asked whether the Council was able to undertake measures to deal with the growing nuisance problem of seagulls on the Blacknell Lane estate. Councillors agreed that some research should be carried out on the question of seagull control and asked the Clerk to follow this up.

The Clerk had accordingly engaged the services of an independent youth service consultant to undertake the assessment, with the objective of providing a report for consideration by Councillors at the January Full Council meeting.
