Minutes of the Annual Meeting of the Joint Burial Committee held on Tuesday 18th June 2024 at 18.45 in the Cemetery Chapel, Townsend Cemetery, Mount Pleasant, Crewkerne.

001 TO ELECT A CHAIRMAN

002 REPORT FROM THE RETIRING CHAIRMAN

Cllr. Borland read a report, noting:

- The Burial Committee had met on five occasions over the past year, and the Chair, Town Clerk, Vice Chair and contractors had met regularly to inspect the site.
- The weather has presented challenges; an exceptionally wet winter has given rise to some sinking graves. Affected plot owners have been notified that Town Council Grounds Staff will re-level with soil as time is available to do so, but that headstone rectification is the responsibility of the plot owner to organise with a mason.
- The large Holm Oak required major works on safety grounds, several tonnes of branches have been reduced to relieve pressure.
- The turning circle was completed with posts, chains, sympathetic signage and a tree planted in memory Queen Elizabeth II.
- Two new sections, one for burials and one for ashes interments, have been plotted out and the new paths are nearly complete.
- In September a successful Open Day was held, with a talk from Tracey Warren of Stoodley & Sons on 'Life and Death in Crewkerne'.

The Clerk reported that arrangements for the war graves plaque were in hand, and the spitfire commemorative plaque had been completed. She reported that she had managed to track down the children of the spitfire pilot, who were hoping to be able to visit Crewkerne in spring 2025. Councillors agreed that the plaque unveiling could be arranged to coincide with this, and a ceremony arranged to incorporate unveiling both plaques, perhaps an 'Open' event and other commemorations in 2025.

A mature cedar had sadly died following an infection with cedar blight, and urgent permission had been granted for its removal, which would be carried out in July, or sooner if possible due to the need to prevent the infection spreading. A specialist had been arranged to take samples from the remaining cedars to assess current infection levels and produce a treatment/management plan.
