
I love this group so much. It's inspired me more at home with our creative sessions. I love that there are multiple stations so my children can engage with what their interests are at the time and this allows me to watch them and direct their learning better at home.

I started coming to awe & wonder with my daughter when I was stuck for inspiration for creative play. We were in a one bedroom flat and felt our space limited us. Constantly doom scrolling through the picturesque "perfect families" on tik tok and instagram thinking I couldn't do it because we didn't have a play room or the perfect craft set. I saw on instagram this free creative group and just losing my job I was suspicious of wasting money on groups that lasted half an hour, for my daughter not to enjoy because it can take her a while for her to warm up. Awe and wonder seemed to fit our budget, timings and our criteria. And it didn't disappoint when we went a long. So many stations and so much space to watch your children develop and grow, and guide you to what they're interested in. I learned more than she did. It inspired me at home to take the simplistic of objects and turn them into a whole afternoon or morning or creative or role playing sessions. Even in the smallest of spaces it's helped open my creative mind.

A&W has had a huge impact on both mine and my daughter's year. I've been really fortunate that I could be a stay at home mum for the past couple years but it has come with a few obstacles. The main thing, I never expected, is how lonely it can be, especially as I had to sell my car so I'm restricted to the groups I can walk to or has a bus / train route. Having A&W in Crewkerne has been amazing! There's a couple other toddler groups but they don't have the same atmosphere. A&W is open, welcoming, light, creative and parent's get involved. I've met a lot of Mum's (and Dad's/other relatives) at the groups that I already knew and made friends with others. It's lovely having somewhere to go, especially in the winter months, that isn't just the park. My daughter has really come out of her shell this year, she often sees her friends at A&W and they'll very happily play together. She's always been into drawing and crafts but it's lovely for her to try something new each session and she's even started liking clay! I recommend it to all the Mums I chat to and everyone who has been has loved it and returned. It's a huge benefit that it's free and the 2 hour sessions are great because we have a little walk to get into town and leaving the house isn't always easy. I've also really enjoyed being involved with the working group this year, it's been nice to have a little bit of involvement, as I used to have a creative job and I do really miss it! I really hope the project continues for years to come, for future parents and children who need a safe space to try new things and meet new people!















1. Purpose

1.1 To consider three current consultations and possible Crewkerne Town Council responses to each.

2. Consultation A: Local Government Boundary Consultation – Electoral Review for Somerset.

2.1 This is a public consultation with views welcomed from individuals and organisations across Somerset Council on where they think new division boundaries should be drawn. LGBC is minded to recommend that **96 councillors** should be elected to Somerset Council in the future.

This is 14 fewer than the current number of councillors.

They are now inviting proposals to help us draw up a pattern of divisions to accommodate **96 councillors**.

- 2.2 In drawing up new electoral divisions, they must balance three legal criteria, namely:
- to deliver electoral equality: where each councillor represents roughly the same number of electors as others across the county;
- that the pattern of divisions should, as far as possible, reflect the interests and identities of local communities;
- that the electoral arrangements should provide for effective and convenient local government.
- 2.3 LGBC will treat all submissions equally, and judge each case on its merits and against the legal criteria.

If you wish to put forward a view, LGBC urges you to ensure that evidence supports your submission.

For example, if you wish to argue that two areas should be included in the same electoral division, make sure you tell us *why* they should be together, providing evidence about community facilities, ties, organisations, and amenities, rather than simply asserting that they belong together.

3. Consultation B: Somerset Council Planning Validation Checklists

- 3.1 Somerset Council is consulting on a new checklist for validating planning applications. The key purpose of the document will be to improve the quality / completeness of planning applications made to the Council so that:
- The Council spends less time (and resource) validating applications and chasing for missing information etc
- Applicants / developers / investors receive a better service as we start processing their applications sooner
- Stakeholders including parish and town councils get consulted on higher quality / more complete submissions and so the proposals they are being consulted on should be clearer
- 3.2 Once adopted, following this consultation, the Validation List will be in operation for two years before it needs reviewing again.

4. Consultation C: MHCLG consultation on remote attendance and proxy voting at council meetings.

4.1 Remote attendance:

The government intends to legislate to give local authorities the flexibility to allow elected members to attend formal council meetings remotely. We believe that this modernising measure of providing broad flexibility to enable remote attendance will have the dual positive impacts of diversifying the representation of those willing and able to stand for elected office and enhance the resilience of local authorities in the face of local or national emergencies.

The intent is that this legislative change would give local authorities the flexibility to allow members to attend remotely.

4.2 Proxy Voting:

Proxy voting is a form of voting whereby a member of a decision-making body may delegate their voting power to another representative to enable a vote in their absence. It is possible some members may find that, due to their personal circumstances, they are temporarily unable to participate in meetings even if remote attendance provisions are in place. Provisions for proxy voting could provide additional flexibility to those who really need it on a time-limited basis, allowing affected members to indirectly exercise their democratic duty, participate in their local authority's governance, and ensure that their views are taken into consideration. In the context of local authorities, the representative would have to be another elected member of the local authority.

1. Purpose

1.1 To consider a request from North Perrott Parish Council (NPPC) for traffic survey funding.

2. Background information

2.1 The following correspondence was recently received by the Mayor:

"I am writing to canvas the thoughts of your councils about a collaborative project to pressure Somerset Council into doing a traffic survey on the A3066 and A356 at our location.

The protracted closure of the A356 for the renovation of the culvert in Misterton and the recent gas works in South Street have concentrated all our minds on the volume and weight of HGVs passing through our communities.

At the time of the Misterton road closure, Cllr Mike Hewitson assured me that this was a concern to all of our councils but that Council officers had refused to conduct a traffic survey on the grounds of cost and no material gain.

The purpose of a survey would be to ascertain if HGVs using the A356 and A3066 actually have business on these routes or should they be travelling on government approved trunk routes such as the A37 and A303?

Depending on the data harvested from a survey, the information could be used to direct efforts to reduce the access of HGVs on our local road network using signage and education.

Without any current data, it is easy for Council Officers to refuse to consider weight limits and redirections that might ease our traffic problems at critical points. It is probably over 20 years since such a survey was last undertaken and it is appropriate that any actions should be taken based on current data.

Residents expressed concern about the speed, volume, and size of vehicles passing through South Street and the Market Square, and the unsatisfactory width of pavements.

We ask Crewkerne Town Council to consider consulting with Somerset Council about introducing a 20mph speed limit and/or alternative traffic calming options.

I will also be bringing this to the attention of Richard Wilkins, Lead Member for Transport and Highways on Somerset Council in the hope a solution can be found.

"As an authority we want to support communities who wish to fund the design and implementation of a 20mph speed limit. It is estimated that the cost would be in the region of £15,000. You will be required to pay a £500 non-refundable application fee which will cover an initial assessment including up to 2 no week-long speed data readings. Note, at our discretion we may be required to collect data from more than 2no locations to determine the suitability. These will be charged at £200 per location and will be included in the final cost of the scheme".
