046 CLERK'S PROGRESS REPORT

The Clerk reported that the paths upgrade in the new section had commenced and was expected to finish by the end of March, weather dependent. The workshop chapel had now received a second coat of plaster and would need time for this to dry out and then a final skim would be applied. She reported that the Operations Manager was seeking quotes for restoring the internal paintwork once finished, and it was noted that a glass break would be installed on the rear wall to monitor movement. The storm damaged noticeboard was repaired and due for reinstatement in the near future.
